*An act relating to the Budget Act of 2008 calling an election, and declaring the urgency thereof, to take effect immediately.*

LEGISLATIVE COUNSEL'S DIGEST

SB 19, as amended, Ducheny. ~~Budget Act of 2008.~~*Elections.*

~~This bill would express the intent of the Legislature to make statutory changes relating to the Budget Act of 2008.~~

*Existing law provides that the Secretary of State is the chief elections officer of the state and requires the Secretary of State to perform specified duties, including preparing and mailing ballot pamphlets, in connection with any statewide election. Existing law further requires the Attorney General to provide for each ballot measure submitted to the voters of the state a ballot title, an official summary, and a ballot label that shall be a condensed statement of the ballot title. Existing law requires that every measure submitted to the voters comply with a specified schedule leading up to the day of the election.*

*This bill would call a statewide special election to be held on May 19, 2009. The bill would place 6 measures before the voters at that election, including (1) a legislative constitutional amendment relating to budget reform, (2) a legislative constitutional amendment relating to education finance, (3) a legislative measure relating to the California State Lottery, (4) a legislative measure relating to Proposition 10*

*approved by the voters at the November 3, 1998, statewide general election, (5) a legislative measure relating to Proposition 63 approved by the voters at the November 2, 2004, statewide general election, and (6) a legislative constitutional amendment relating to the pay of state officers in the event there is an operating deficit in the state budget. This bill would further set forth language to be used for the ballot labels and the ballot titles and summaries for those measures. In addition, this bill would waive certain statutory deadlines for placement of those measures before the voters at the May 19, 2009, statewide special election, and would specify that the ballot label public examination period be limited to 8 days.*

*This bill would place before the voters at the June 8, 2010, statewide primary election a legislative constitutional amendment relating to open primary elections. This bill would also set forth language to be used for the ballot label and the ballot title and summary for that measure.*

The California Constitution authorizes the Governor to declare a fiscal emergency and to call the Legislature into special session for that purpose. The Governor issued a proclamation declaring a fiscal emergency, and calling a special session for this purpose, on December 19, 2008.

This bill would state that it addresses the fiscal emergency declared by the Governor by proclamation issued on December 19, 2008, pursuant to the California Constitution.

*This bill would declare that it is to take effect immediately as an act calling an election.*

*This bill would declare that it is to take effect immediately as an urgency statute.*

 35 other provision of law, the translations of the ballot titles and the  
 36 condensed statements of the ballot titles required pursuant to  
 37 Section 9054 may be made available for public examination at a  
 38 later date than the start of the public examination period for the  
 39 ballot pamphlet, provided that the translations of the ballot titles

1 *and the condensed statements of the ballot titles must remain*  
2 *available for public examination for eight days.*

3 *(c) Notwithstanding Section 13282 of the Elections Code or any*  
4 *other provision of law, the public shall be permitted to examine*  
5 *the condensed statements of the ballot titles for eight days. Any*  
6 *voter may seek a writ of mandate for the purpose of requiring the*  
7 *condensed statements of the ballot titles, or portions thereof, to*

33 *financial impact summary prepared pursuant to Section 9087 of*  
34 *the Elections Code and Section 88003 of the Government Code.*  
35 *The ballot label is the condensed statement of the ballot title and*  
36 *the financial impact summary.*

37 *(c) (1) Notwithstanding Sections 9050, 9053, and 9086 of the*  
38 *Elections Code or any other provision of law, the Secretary of*  
39 *State shall use the following as the ballot title and summary for*  
40 *the measure described in subdivision (a):*

2     “PRIMARY ELECTION PROCESS REFORM. GREATER  
3 PARTICIPATION IN ELECTIONS. Encourages increased  
4 participation in elections for congressional, legislative, and  
5 statewide offices by reforming the procedure by which candidates  
6 are selected in primary elections. Gives voters increased options  
7 by allowing all voters to choose any candidate regardless of the  
8 candidate’s or voter’s political party preference. Ensures that the  
9 two candidates receiving the greatest number of votes will appear  
10 on the general election ballot regardless of party preference. Does  
11 not change primary elections for President, party committee offices,  
12 and nonpartisan offices.”

30 for the June 8, 2010, statewide primary election, mailed pursuant  
31 to Section 9094 of the Elections Code, the information specified  
32 in Section 9084 of the Elections Code regarding the measure  
33 described in subdivision (a).
